Title of IFIB : Provision of removal of waste services for the SHAPE compound and management of the SHAPE Recycling Centre.  
Requirement : The requirement is for the provision of removal of waste services for the SHAPE compound and management of the SHAPE Recycling Centre. The prospective contractor shall be able to perform the following types of services: collection and removal of inert, household and similar waste from SHAPE compound facilities; collection and removal waste; collection and removal of hospital waste; removal of recyclable waste from the SHAPE Recycling Centre; management of the SHAPE Recycling Centre.

Period of performance : One base year (2019) + 4 (four) one-year options  
Bidding procedure : Lowest technically compliant bid  
Funding : SHAPE Military Budget (estimated yearly amount: 370 KEURO)

: Estimated total cumulative value of contract: 2.5 MEURO

Closing Date : September 2018 planned

Eligibility : Firms (1) that originate and are chartered/incorporated within one of the 29 NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the 29 NATO-member nations, (3) that possess a valid NATO security clearance up to NATO SECRET level, and (4) that have performed at least three contracts within the last five years substantially similar in scope and magnitude to the requirement described in the solicitation.
