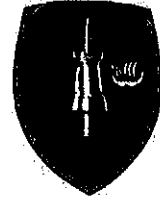

Requirement: Aim of this IFIB is to obtain a contract for the provision of Internet Service at HQ RESOLUTE SUPPORT (RS), Kabul (AFG). The Internet Bandwidth Service Provider will provide a single point of entry for Internet service onto the RS HQ complex and will provide Internet services for a consolidated, monitored, and managed solution. The Provider will have a telephone number for reporting problems by the Customer's CIS personnel. This number will be monitored 24/7 by the Provider by a technician capable of conversing in English. The Provider will also be responsible to monitor their provision of services and provide reports on all reported incidents, their cause, and resolutions.
