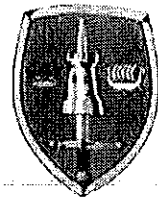

SUBJECT: **NOTIFICATION OF INTENT (NOI) TO ISSUE AN INVITATION FOR INTERNATIONAL BIDDING (IFIB) FOR THE OPERATION OF A TAX FREE RETAIL BUSINESS AT HQ JFC BRUNSSUM (HQ JFCBS), THE NETHERLANDS.**

1. In accordance with the stipulations of the Bi-SC procurement Directive 60-70, Annex C, the following information is provided on an Invitation for International Bidding (IFIB) that this Headquarters has the intention to release.

IFIB reference number: IFIB-ACO-BRU-16-05

Title of IFIB: Operation of a Tax free retail business at HQ JFC Brunssum, The Netherlands.

Requirement: Aim of this IFIB is to obtain a contractor for the provision of a tax free retail business at the following premises: HQ JFCBS, Eibergen (1st German/Netherlands Corps) and on a Web Portal.

Type of contract: IFIB, Firm Fixed Price (FFP) Indefinite Delivery Indefinite Quantity (IDIQ) contract (concessionaire contract).

Period of performance: 1 December 2016 to 31 December 2017 (one base year plus four options years).

Bidding procedure: Sealed bid with three envelopes (administrative, technical and price proposal).

Funding: Individual consumers under the JFCBS Morale and Welfare Program with an anticipated volume of business of 3.200.000,00 euros per year, for an estimated amount of 16.000.000,00 euros for the basic period plus options.

Eligibility: Commercial entities that originate or are incorporated within NATO-member nations and that provide the funding for JFC in accordance with Bi-Sc Dir. 60-70; and which have performed at least two contracts within the last five years substantially similar in scope to the requirement described in the solicitation.

Delivery locations: Brunssum (The Netherlands), Eibergen (The Netherlands) and a Web Portal.

Partial bidding: Partial bidding is not authorized.


