

In accordance with the stipulations of the Bi-SC Directive 060-070, Annex C, the following information is provided for an Invitation for International Bidding (IFIB) that this Headquarters has the intention to release:

Title of IFIB: Enterprise Accounting System for the Morale Welfare Activities (MWA) Organization at JFC Naples, Lago Patria, Italy

Requirement: The JFC Naples MWA Organization requires a robust accounting system for its retail and non-retail operations. The accounting system, at a minimum, must produce commonly-used financial reports (i.e., Balance Sheets, Income Statements), link commercial accounting operations with other activities within MWA (i.e., procurement and supply management, point of sales, inventory, cash management), and manage the sale of rationed items.

NATO is modernizing the MWA operations and integrating aspects of the operation to include the procurement process, inventory management, cash management, point-of-sale operations, and accounting. The accounting software system must be suited for a Small and Medium size Enterprise (SME) as classified by the European Commission based on a payroll of 50 local Italian employees and annual revenues of approximately €12M euro.

Type of Contract: Firm Fixed Price

Period of Performance: One Base year beginning 01 January 2017 includes system development, testing, and integration of a commercial-off-the-shelf (COTS) system, with a further four (4) one-year extension options as per para. 2-12 (b) of above mentioned directive.

All eligible companies must demonstrate that they have successfully performed at least one (1) contract in the last three (3) years substantially similar in scope and magnitude to the requirements described in this solicitation.
