- 1. The NATO Support and Procurement Agency (NSPA) has been designated by the NATO Investment Committee as Host Nation for the implementation of Minor Works Projects 5HQ27022-M and 5HQ27023-M. One portion of these projects is for the provision of 20-ft ISO containers for the Small and Medium HQs Camps, which are part of the Capability Package (CP) 5A0156 "NATO Deployable HQ Assets".
- 2. The International Competitive Bidding (ICB) will be conducted in accordance with reference 1, which stipulates that the host nation, at the earliest possible moment, issues a Notification of Intent (NOI) to Invite Bids to the diplomatic representative of the participating countries in the capital of the host nation. This letter is issued following approval of the project by the Infrastructure Committee (IC) at reference 2.
- 3. This letter constitutes a NOI to Invite Bids for provision of **20-ft ISO containers for NATO Small and Medium HQs Camps** as further described in Annex A.

SUMMARY DESCRIPTION AND COST ESTIMATE OF PRESENT NOTIFICATION

A) GENERAL

NSPA has been designated Host Nation for the acquisition and follow-on support of CP 5A0156 "NATO Deployable HQ Assets".

The following information contains excerpts from the Statement of Work that will be released during the ICB.

1.1. Project Objectives

- **1.1.1** The Contractor shall furnish to NSPA, standard 20 ft ISO containers required for the storage and transportation of the Deployable HQ assets for rapidly deployable NATO military forces. The timely provision of the ISO containers is a key to economical transport of the material procured.
- **1.1.2** The containers shall be designed to support operations of the deployable assets under the following circumstances:
 - a. Stored outdoor until needed;
 - b. Deployed on operations/exercises requiring rapid loading and unloading;
 - c. Transported by sea, land or air, including by C-130 aircraft; and
 - d. Deployed on operations where the condition of the container will need to satisfy the safe and secure operation of equipment transport for up to 2 years without significant maintenance or repair, and without damage to its contents.
- **1.1.3** The quantity of new ISO containers $6,058 \times 2,438 \times 2,438 \text{ mm}$ /20 x 8 x 8 ft (Length x Width x Height) required has been estimated based on the volume of materiel to be stored inside and is **up to 300 ea**.
- 1.1.4 Configurations. The containers shall meet one of the following specifications:
 - 20 ft ISO containers with opening at one end;
 - 20 ft ISO containers with openings at both ends;
 - 20 ft ISO containers with opening at one end plus "full" opening at one side.
- **1.1.5** The delivery of containers will be staggered for two years, 2016 and 2017, through an Outline Agreement, to match the delivery of the material to be stored in them.

ESTIMATED VALUE FOR THIS CONTRACT: 1,400,000 EUR

a. DELIVERY

First batch of containers: 3 months after contract award.

b. PARTIAL BIDDING

No partial offers will be accepted.

No follow on services are envisioned at this stage.

No optional requirements at this stage.

e. **QUALITY ASSURANCE**

Requirement for Quality Assurance is included.

f. SECURITY LEVEL REQUIRED

6. LANGUAGE

- 1) "Cahier des Charges" and subsequent procurement contracts will be in English language.
- 2) Offers and any communication to be made by the bidders, and any technical data or documentation to be furnished by the contractors must be also in English.

C) FINAL CONSIDERATIONS

- a. NSPA intends to issue the Invitation for Bids (IFB) to interested firms at a date yet to be determined, but not before 27 June 2016. The bidders will be allowed not less than 42 calendar days to reply to the relevant IFB.
- b. The bids to be submitted in response to the NSPA IFB mentioned above must be valid for a period of 180 days.
- c. The envisioned bidding method is the "One Step International Competitive Bidding Procedure".
- d. The information to be provided to the bidders will be up to NATO UNCLASSIFIED.
- e. Please note that actual quantities to be included in the Invitation for Bid may vary slightly from those specified in this NOI.
