Dear Sir/Madam,

The DMO of the Netherlands Ministry of Defence is responsible for the procurement of defence material for the four (4) Operational Commands (Royal Netherlands Army, Royal Netherlands Air Force, Royal Netherlands Navy and Royal Netherlands Military Police) and the Dutch Coast Guard.

The Netherlands Ministry of Defence (MoD) and the Coast Guard makes use of HF radio communications services to carry out their operational tasks in a global setting. To optimize this radio services the DMO started a program of three important projects. This first one is the modernization and reducing of 12 HF locations to 6. The second one is modernization and integration of the HF Facilities at HF locations (Communications Centers, transmit and receive sites). This project is also known as BRASS. In this case "BRASS" shall be interpreted as BRASS-ICC including the enhancement one (BRE1TA).
